**Clothes Recycling Bank. ASTCO.** The Parish Council has decided to site the bank in the Play Park next to the entrance gate on Dunham Close. The bank has been delivered.

The siting will be supervised by Cllr Arden.

## 04.07 New Build on the Playing Field. Primary School and Parish Council.

In order to ascertain whether the Playing Field has been registered as Village Green land the Parish Council needs sight of the Land Transfer document for definition and any Covenants. West Lindsey District Council has been contacted but was not able to help. The Clerk is now in contact with Lincolnshire County Council. If the land has been registered as Village Green land, any building development will initially be barred.

## 04.08 New Village Signs. (Cllr Goodacre).

The quotation was in excess of £8000.00 for the two signs. This was considered too expensive at the present time and the project has been deferred.

# 05.09 Planning.

The item of planning which was rejected before being "called in" is now under review due to a technicality and is to be re-submitted. The Parish Council will not now be submitting a complaint but will be asking for the new application to be called in if there is a possibility that it could be rejected.

**Reduction in Speed limit to 50mph:** Cllr Arden has been in contact with Cllr Butroid of Lincolnshire County Council. The business is ongoing.
